1. Introduction

Welcome to the Irish Human Rights and Equality Commission (IHREC)'s e-learning website. Please read these Terms and Conditions of use carefully which govern IHREC's relationship with you in relation to this website.

2. Definitions

For the purposes of these terms:

- 'We' and 'us' means IHREC who will provide the services to you.
- 'You' means the learner receiving the services.
- "The site" means www.elearning.ihrec.ie.
- "Site services" means the services which can be accessed on www.elearning.ihrec.ie

3. General

- **3.1.** These terms are a contract between IHREC and you where you sign up as an individual in a personal capacity.

4. Registration and acceptance
